CONSENT RELATING TO PERSONAL INFORMATION

 - from time to time during the Client's and my course of dealing with you, in the future to make further investigations and (ii) verifications of the nature described herein and further share Information for the purposes described herein; and
 - (iii) from time to time (including after termination of the Client's and my dealings with you), to respond to inquiries from, and exchange any Information with, third parties (including credit reporting agencies, financial institutions, creditors, vendors and other persons) concerning our credit rating, financial capacity and payment history or as required by law;
- I acknowledge that you have a direct business requirement for the Information in connection with a business transaction or a credit (e) transaction involving me and/or the Client;
- I further consent and authorize you, your agents, contractors, employees and representatives to share the Information (including (f) Personal Information) among yourselves and with third parties from time to time in order:
